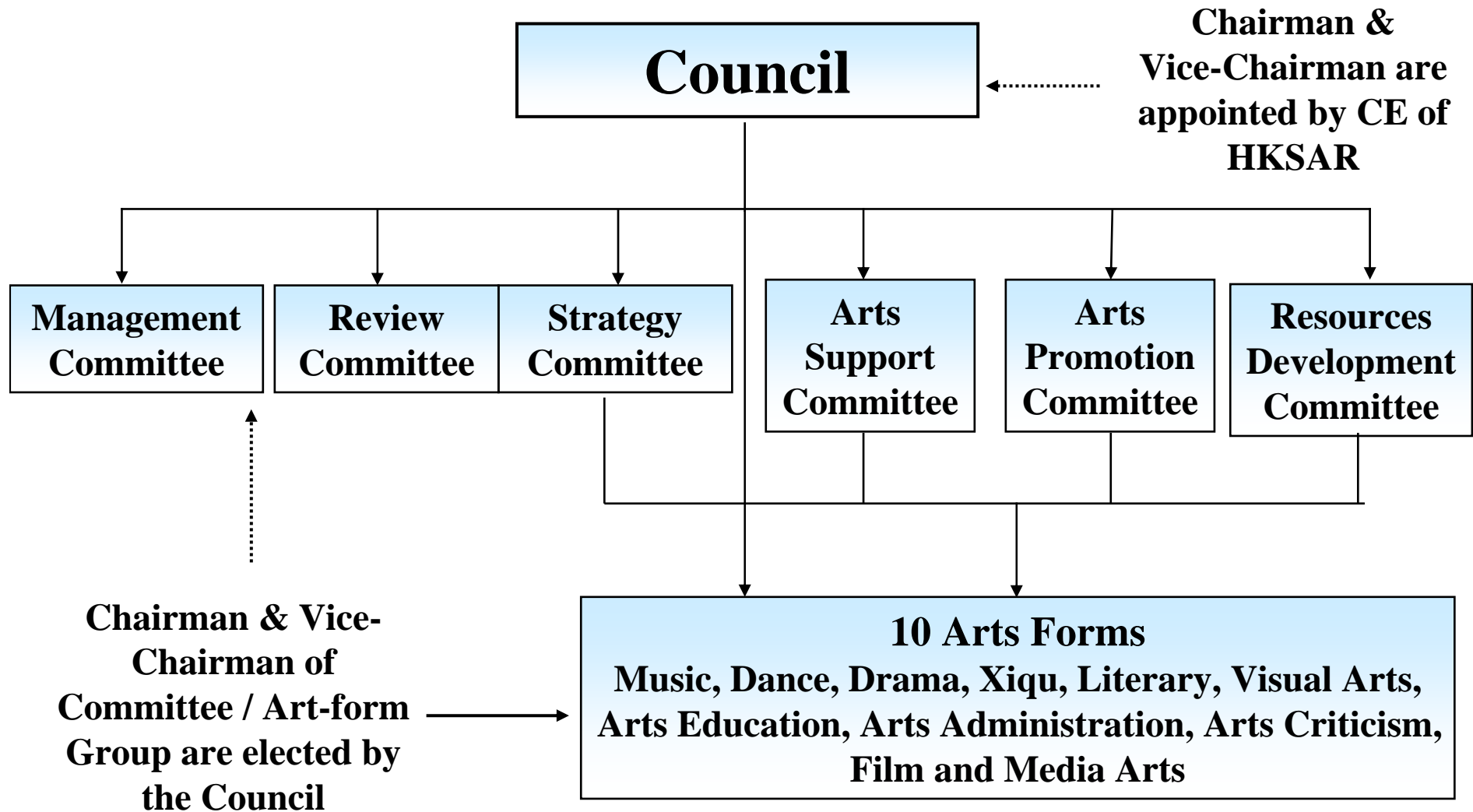

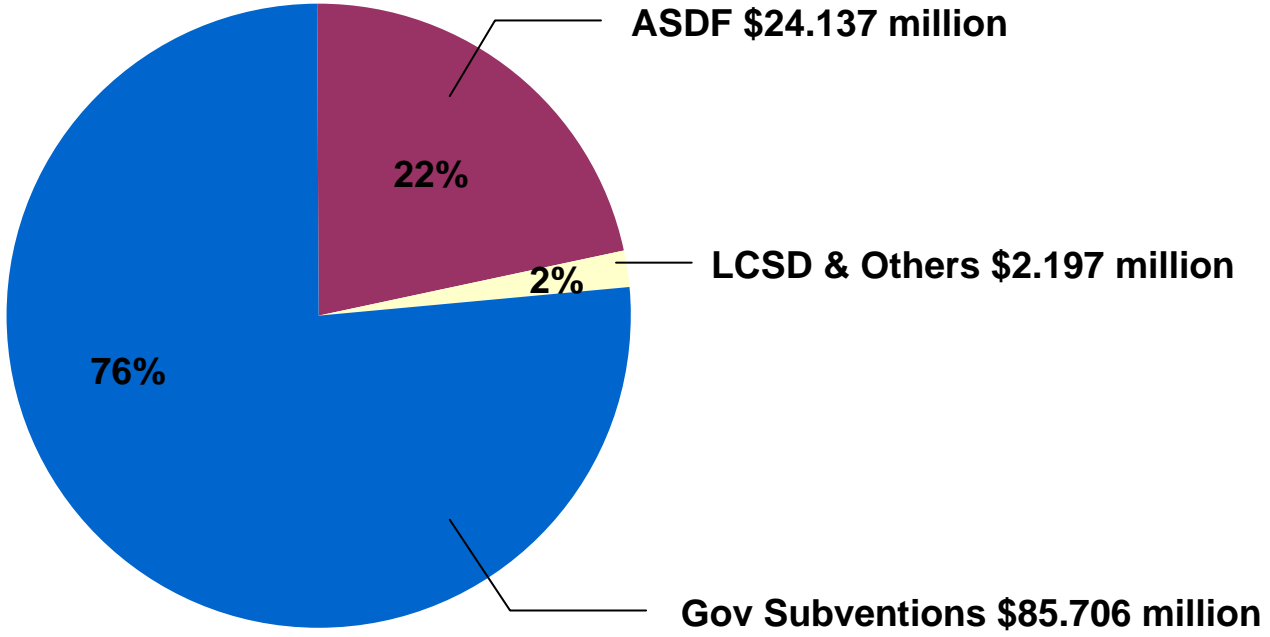

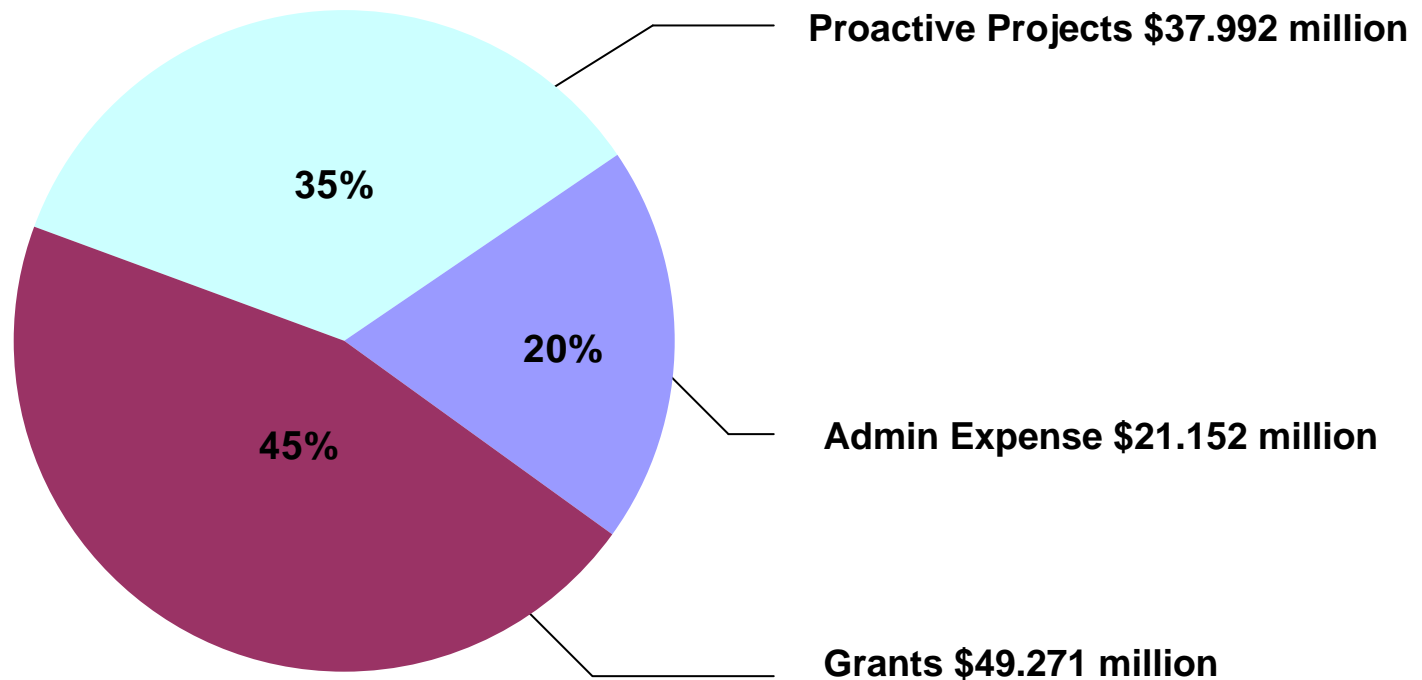
Income Breakdown for 2008/09
