I understand that any false information wilfully given or the withholding of any material information will result in the disqualification of the concerned applicant(s) from participation in the nomination exercise.

**Remarks:**

- 1) The Nomination Agent (that is, PR Concepts Asia Limited) is the final authority to determine the eligibility of the applicants and the organisations concerned. The interpretation of the Nomination Agent on the Guidelines for Voter Registration and the Voter Registration Form of this nomination exercise is final.
- 2) A complaint in relation to the nomination exercise can be made to the Nomination Agent or the Project Manager of the Nomination Agent.
- 3) If the matter cannot be satisfactorily resolved, or if the complainant still feels aggrieved or if the complaint is directed at the Nomination Agent or the Project Manager of the Nomination Agent personally, it should be addressed to the Principal Assistant Secretary (Culture)<sup>1</sup> of the Home Affairs Bureau.
- 4) The Nomination Agent will retain the personal data and other information contained in this form for the conduct of the nomination exercise. After the nomination exercise, all such data and information will be transferred to the Home Affairs Bureau or other departments concerned for record.
